

## **Grand Finale Parade Rules**

DeKalb County Free Fall Fair Saturday, October 1, 2022 at 10:00 am

All entries require a \$30 per unit entry fee. This is due at the time the application is received.
Your unit will be turned away the day of the parade if your entry fee has not been received.
All entry fees are non-refundable.

- 2. ALL entries will need to provide Proof of Insurance Form before they can be given a position in the parade route. **See example below.**
- 3. All entries are strongly encouraged to submit information about your entry that can be announced as you are passing by the Judge's Stand.
- 4. Deadline for applications and entry fee is Friday, September 23, 2022.
- 5. You will be notified of your lineup position by email or telephone no later than Wednesday, September 28, 2022.
- 6. Parade Route: Starting on Main Street South of 19th Street. It will proceed North on Main Street then East on 10th Street to Union Street. Continue North on Union to 4th Street then West on 4th Street to Jackson Street. The parade will proceed South on Jackson Street to 13th Street and will disband by Eckhart Library.
- 7. Judging will take place at the Review Stand located at 9th & Jackson Streets on the West side located in front of the Auburn Post Office.
- 8. Due to heavy traffic in parade lineup areas, many streets will be blocked off.

PLEASE USE THE FOLLOWING STREETS: 15th Street and Ensley Avenue for East-West movement Union or VanBuren Streets for North-South movement

- 9. NO ITEMS ARE TO BE THROWN FROM THE VEHICLES INTO THE CROWD! You may walk and hand out items to spectators to ensure safety for everyone.
- 10. ALL equestrian entries MUST have a clean-up crew at the end of their entry or they will not be allowed to go through the parade and will forfeit their entry fee.
- 11. All units must complete entire parade route and abide by the rules to be eligible for prize money. Awards will be posted the day of the parade by 6:00 p.m. at the fair trailer located on the corner of Cedar & 9th Streets. Checks for all prizes will be mailed by the end of October.
- 12. Restrooms are available at the Fairgrounds (14th & Union Streets) and at Eckhart Park (Cedar Street & Ensley Avenue)
